Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

Applicability. The Form HUD-50075-HCV is to be completed annually by **HCV-Only PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, Small PHA, or Qualified PHA do not need to submit this form. Where applicable, separate Annual PHA Plan forms are available for each of these types of PHAs.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS and SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

The Tuscarawas Board of Commissioners passed a resolution (Resolution 24-13) to continue to use our previous Administrative Plan until HUD is ready for the Housing Opportunities Through Modernization Act (HOTMA) rollout, at which time our new updated Administrative Plan would take effect, and HOTMA will be implemented.</p>

B.3	<p>Progress Report.</p> <p>Provide a description of the PHA’s progress in meeting its Mission and Goals described in its 5-Year PHA Plan. The Tuscarawas MHA has consistently assisted eligible families with safe, decent, and affordable housing, without discrimination while adhering to Federal laws, HUD regulation, and budgetary constraints. TMHA continues to be involved with local ‘Continuum of Care’ programs. Through an agreement with the local ADAMHS Board that handles intake and initial eligibility determination and TMHA provides HQS inspections, annual and interim re-certifications and distribution of HAP & UAP checks. TMHA has previously administered, as a contracted service provider, funding through 4 local CHIP grants with a combination of short-term rental assistance and/or security deposit assistance.</p> <p>TMHA continued to serve new families from its waiting list throughout the year, while at the same time maintaining assistance to those families already participating in the Section 8 HCV program. Families are assisted in units in all areas of Tuscarawas County. In order to maximize the number of units available to participating families, TMHA recruits new landlords each year. TMHA maintains open communication with landlords who need assistance to understand HUD regulations regarding Housing Quality Standards (HQS), the current implemented guidelines on National Standards for the Physical Inspection of Real Estate (NSPIRE), and Lead-based Paint regulations. TMHA continues to loan its HEPA Vacuum to landlords and other residents who have need of it in an effort to eliminate the effects of lead-base paint poisoning.</p> <p>TMHA actively fosters collaboration with local agencies and non-profit organizations who clients can benefit from our voucher program. TMHA is a member of the Housing, Opportunities, Monitoring, Education (HOME) Network (which is the local Continuum of Care collaborative), and the Ohio Coalition on Homelessness and Housing in Ohio (COHHIO). In addition, TMHA staff actively cultivates an ‘open line’ style of communication with other area agencies that serve shared clientele in order to minimize barriers in serving those in need. TMHA participates with the County and local cities by serving on local Housing Advisory committees that formulate the jurisdictions’ Community Housing Improvement Surveys (CHIS) and the Impediments to Fair Housing needs priority surveys. In the above ways, TMHA has earned a reputation as being a respected and accountable community resource for housing of low-income families.</p> <p>TMHA has an active HCV Home Ownership Program, with two families who continue to maintain home ownership. TMHA also maintains an active Family Self-Sufficiency Program (FSS), and has consistently maintained enough active families to warrant two part-time FSS Coordinators. There are currently 66 families enrolled in TMHA’s FSS program. In the past year 10 participants have successfully completed contracts of participation and graduated from the program.</p> <p>TMHA has continued to affirmatively further fair housing by providing fair housing information with every new tenant briefing packet and instructional video/meeting. Fair Housing posters and brochures are prominently displayed in the TMHA office lobby. When TMHA receives calls or complaints regarding fair housing issues, those families are immediately referred to the local fair housing agency to address their questions and concerns.</p> <p>TMHA also continues to address the housing needs of disabled families within our jurisdiction. TMHA administers thirty (30) Non-Elderly Disabled (NED) Vouchers which can only be utilized by disabled families. No individuals or families are denied benefits or services due to their disabilities.</p> <p>TMHA has also maintained active participation with the Ohio Housing Authorities Conference. TMHA staff attend OHAC sponsored training in order to remain current with assisted housing regulations and best practices.</p> <p>On the FYE2024 SEMAP submission, TMHA earned a High Performer designation from HUD. TMHA will strive to meet all the expectations required of us under each of the applicable SEMAP Indicators to retain our High Performer status.</p>
